<p>Pre-Project Conditions</p> <p>Native American communities face a high and disproportionate burden of asthma compared to other populations. Additionally, Tribal communities along the US/Mexico border within US EPA Region 9 also face social and environmental inequities such as inadequate access to high quality healthcare, high prevalence of substandard housing, and high levels of outdoor air pollution – factors that contribute to poor asthma outcomes. Asthma home visiting services are an intervention proven to improve asthma outcomes, reduce healthcare costs, and reduce health disparities. But access to these services is limited and/or non-existent.</p>
